If you are concerned that an adult or child at risk, is in immediate danger,

Contact police immediately on 999

## **Immediate Risk – Call 999**

#### **High-Risk indicators below:**

Serious Harm: Severe distress and/or physical/psychological harm. Risk of homicide, suicide, or self-harm.

**Likelihood of Harm:** Assess frequency - is it happening daily or at every opportunity. living together or apart. Is the person planning to leave **Beyond Physical Harm:** Include non-physical risks like harassment, control, coercion and stalking, Is it honour based?.

Impact on Children: Children witnessing or experiencing abuse are also victims. Whether it is direct or indirect experiences.

**Escalation and Cumulative risk:** Note any increase in incidents – or consider previous incidents, number of hearings at MARAC etc. Ensure you consider the combination of previous and current incidents. Considering the level of impact on the victim and family.

If HIGH-RISK follow the steps below-

If not immediate but you are concerned it is High-Risk (see above) - Assess and refer the person at risk:

If unsure talk to a Domestic abuse service/professional or call a multi-agency meeting!

#### **MEDIUM** - Risks and Concerns Present But Not Immediate.

#### Risk = Harm + Likelihood

•Harm: Can be physical or psychological. Consider the impact, duration of abuse, and recovery needs.

•Likelihood: Is harm ongoing or likely to recur? Assess frequency, duration, and context. Identify existing strengths, strategies, and support that could reduce risk.

•Escalation and Cumulative risk: Note any increase in incidents – or consider previous incidents, amount of hearings at MARAC etc. Ensure you consider the combination of previous and current incidents. Considering the level of impact on the victim and family.

#### Assess the person at risk:

When safe to do so -

Discuss their concerns and yours, be patient and understanding.

Use this guide <u>Domestic Abuse Stalking & Harassment (DASH) checklist</u> to help you.

If the person meets the MARAC criteria go to 'Immediate Risk' above.
