


Themes of the Quarter

We have had a slight increase in number of contacts to the last newsletter analysis in Q2 (2249 in Q2, 2394 in Q3), and a similar amount that have progressed to CSC (14% in Q2, 13% in Q3)




Themes of the Quarter

We have seen an increase in Level 1 and Level 3 outcomes compared to Q2. There has been a decrease of around 100 contact outcomes for Level 2.










Themes of the Quarter

Family Dysfunction and Neglect remain the top two contact reason for Q4. We have seen a 78% increase in referrals from schools since Q2 (359 in Q2 to 641 in Q4)



A REMINDER ABOUT CONSENT



The only exception to this is if it is suspected that a parent has intentionally caused harm to their child/ren, and they have suffered significant harm or are at ongoing risk of suffering significant harm.

It has been noticed that there has been an increase in professionals stating that they have not gained parental consent as they do not wish to negatively impact their relationship with the family by informing them that a concern has been raised. This is a reminder that professionals cannot remain anonymous when reporting a concern and the COMPASS senior social workers WILL inform the parent of the referrer's details.

Professionals should be aware that parents always question why they had not been informed that a concern was going to be or had been raised, they want professionals to be transparent and honest with them and by not informing them this will have a more detrimental impact on the professional/ parental relationship. When recording in the MARF that consent has been gained please can you specify from whom and please do not leave this section blank or unanswered.





SPOTLIGHT ON THRESHOLD

COMPASS continue to receive a high level of inappropriate referrals which do not require a Level 4 threshold response. Schools and the health service remain the agencies who make the most referrals which do not reach threshold and where support can be provided at Level 2 or 3. Our data demonstrates that only 13% of concerns raised reach the threshold for a S17 or S47 response and therefore the Early Help pathway should have been followed. Information in relation to this pathway can be seen in slide 10.

Before raising concerns in COMPASS please refer to the threshold document which gives clear guidance as to the appropriate level of support.


This is a reminder that MARFS should only be completed for concerns that are deemed to meet Level 4 of the threshold document.
